Statutory Contribution

The compulsory contribution covers the risks of old age, death, invalidity, industrial injury and occupational disease, and for pensions and supplementary benefits. It also covers children's allowance, social assistance and the services under the Health Scheme. Every person who has passed his/her sixteenth birthday, but has not yet reached his/her retirement, shall become insured under this Act either as an employed person or as a self-employed person, or as a self-occupied person if not exempted as stipulated in the provisions of Article 6, and Article 12 (1) of the Social Security Act (Cap 318).

All cash benefits are administered by the Department of Social Security (*Dipartiment tas-Sigurta' Socjali*).

Supervision

The Ministry for the Family and Social Solidarity (*Ministeru għall-Familja u s-Solidarjeta' Socjali*) is responsible for the supervision of the benefits paid by the Social Security Department; to actively promote, facilitate and contribute to the ongoing development of an inclusive society through the provisions of quality-personalised services and by actively encouraging and assisting individuals, families and community associations to participate in fighting social exclusions, ensuring equal opportunities for all, with specific emphasis on the most vulnerable members of society.

The Ministry for Energy and Health (*Ministeru għall-Energija u s-Saħħa*) is responsible to provide health care services and the necessary monitoring and control mechanism, to actively promote and contribute to the well-being of the elderly people and the community care.
